

ZeroTier Secure Sessions Protocol

1 Introduction

We introduce the *ZeroTier Secure Sessions Protocol* (ZSSP), a quantum forward secure, post-compromise secure, FIPS compliant transport protocol built using the Noise protocol framework and incorporating ideas from both WireGuard and Signal [1] [2] [3].

While excellent alternatives such as WireGuard, Signal, QUIC, and modern TLS exist, we were led to develop ZSSP because none of these offered all of the following in a single protocol: excellent performance under high load, support for widespread hardware acceleration, FIPS/NIST compliant algorithmic primitives, attack-resistant support for fragmentation, anonymity and post-compromise security [4], and a simple and parsimonious design.

The ZSSP reference implementation is written in less than 4000 lines of Rust (excluding cryptographic primitives) and will be made available under an open source license (TBD but likely the Mozilla Public License). We intend for ZSSP to be forever unburdened by copyright and patent.

2 The Noise Protocol

ZSSP, at its core, is an implementation of the Noise protocol framework [1]. To understand the following section, we will assume a basic familiarity with the Noise protocol. We will primarily be explaining ZSSP in relation to the specification of the Noise protocol.

Within ZSSP, initial contact between an initiator, Alice, and a responder, Bob, is performed using the Noise protocol named

`Noise_XKhs+psk2_P384+Kyber1024_AESGCM_SHA512`.

`Noise_XK` specifies we are implementing Noise XK. `psk2` specifies we are using a preshared symmetric key (PSK) used on the second message of the handshake. `P384` specifies we are using elliptic curve P384 as our FIPS compliant Diffie-Helman (DH) primitive [5]. `AESGCM` specifies we are using the AES block cipher in Galois/Counter Mode as our symmetric primitive [6]. `SHA512` is our FIPS compliant hash function [7]. And finally, `hs` and `+Kyber1024` specifies we are adding hybrid forward secrecy onto Noise using an ephemeral Kyber1024 handshake [8].

ZSSP is cryptographically opinionated, as in ZSSP is only implemented in terms of the P384, Kyber1024, AES, and SHA-512 cryptographic primitives. There is no cipher suite negotiation within ZSSP, if one of the cryptographic primitives of ZSSP contains a critical weakness a new version of ZSSP will have to be created. We believe that in the modern era, with strong, standardized cryptographic algorithms available, this is a strict advantage to security. Importantly, this will simplify tremendously any future mathematical analysis of ZSSP.

2.1 Federal Information Processing Standards

The Federal Information Processing Standards (FIPS) are a broad set of electronic security standards created by National Institute of Standards and Technology (NIST). Many American institutions, namely financial and governmental institutions, want to use modern cryptographic protocols, but are explicitly forbidden by FIPS to do so. This is because a lot of modern cryptographic protocols use modern cryptographic primitives

which themselves are not approved under FIPS. FIPS, as a security standard, has been widely criticized by the cryptographic community [9] [10].

To create a protocol that achieves FIPS compliance, we must use cryptographic primitives which are approved by FIPS. For this reason ZSSP is implemented in terms of the primitives AES-GCM, SHA-512, P384 and KBKDF. We have taken much care to make sure these are amongst the most trusted and used within FIPS. These primitives, so long as they are used correctly, are considered very secure and extremely unlikely to be broken.

2.2 Key Derivation Function

There is one major difference between ZSSP and the Noise protocol, and that is our choice of key derivation function (KDF). Noise specifies the use of HKDF [11], however FIPS requires the use of a FIPS compliant KDF. This gave us two options, we could either modify HKDF to pass any output key through an additional FIPS KDF, or we could entirely replace HKDF with a FIPS KDF. We decided that the later option, replacing HKDF with a FIPS KDF, would be simpler and safer to implement.

We use NIST's current recommendation for an HMAC based counter mode KDF [12] from section 4.1. This KDF is very comparable to HKDF in terms of both construction and security properties, and so we believe it is a safe alternative.

Let $\text{KBKDF}(K_{IN}, \text{Label}, \text{Context}, L)$ be the KDF described in section 4.1 of NIST SP 800-108r1. To replace HKDF, we simply replace every occurrence of HKDF in the Noise specification with KBKDF. More specifically, within our implementation of Noise, we set the function HKDF to be the following:

```
HKDF(chaining_key, input_key_material, num_outputs) :=
    KBKDF(input_key_material, "ZSSP", chaining_key, 512 * num_outputs)
```

Reducing the above with the definition of KBKDF, we get that $\text{HKDF}(\text{chaining_key}, \text{input_key_material}, \text{num_outputs})$ is implemented as follows:

- Sets $L = 512 \cdot \text{num_outputs}$, stored as a 16-bit big-endian integer.
- Sets $\text{output1} = \text{HMAC-HASH}(\text{input_key_material}, 0x01 || \text{"ZSSP"} || 0x00 || \text{chaining_key} || L)$.
- Sets $\text{output2} = \text{HMAC-HASH}(\text{input_key_material}, 0x02 || \text{"ZSSP"} || 0x00 || \text{chaining_key} || L)$.
- If $\text{num_outputs} == 2$ then returns the pair $(\text{output1}, \text{output2})$.
- Sets $\text{output3} = \text{HMAC-HASH}(\text{input_key_material}, 0x03 || \text{"ZSSP"} || 0x00 || \text{chaining_key} || L)$.
- Returns the triple $(\text{output1}, \text{output2}, \text{output3})$.

2.3 Additional Symmetric Keys

The Noise protocol only establishes two symmetric keys to be used for data transport. One of these keys is used for Bob to send data transport packets to Alice, and the other is used to send packets in the opposite direction. If we want to obey the principle of protocol design that each key should be used for one and only one purpose, having access to only these two keys is entirely insufficient. Additional symmetric keys (ASKs) are needed.

To motivate the need for ASKs further, consider that many authenticated key exchange (AKE) protocols require some kind of final "key confirmation" packet or packets to confirm that both parties have successfully derived the same transport keys. The most common key confirmation mechanism is to send the other party some AEAD payload encrypted using one of the data transport keys. However this is a violation of the principle that each symmetric key should be used for one purpose. In this specific example, the transport key is being explicitly used as a component of the key exchange. This, for technical reasons beyond the scope of this paper, makes it impossible to formally prove the protocol secure in standard models of AKE security [13]. This issue would be avoided if an ASK was used to authenticate the key confirmation, instead of the transport keys.

The maintainers of the Noise protocol are aware of the need for ASKs, and are in the process of extending the protocol with an ASK mechanism [14]. However, at this point in time this mechanism is still unofficial and may be replaced. It also uses specific capabilities of HKDF that KBKDF does not have. For that reason we have created our own ASK extension to the Noise protocol, based on the unofficial mechanism.

We add a function, `GetAsk(label)`, to the Noise protocol that takes as input a static string, and produces as output two 256-bit keys. This function is implemented as a component of the Noise handshake state machine, and so it has access to the most recent values of the Noise handshake hash, `h`, and the Noise chaining key, `ck`. To preserve consistency with ‘MixKey’ and ‘Split’, we will produce two 512-bit hashes, and then truncate each to 256-bits to produce two keys.

$$\text{GetAsk}(\text{label}) := \text{KBKDF}(h, \text{label}, ck, 1024).$$

Due to the nature of KBKDF as a key derivation algorithm, we expect every symmetric key produced by `GetAsk(label)` with a unique label to have the following security properties:

- Security equivalence to transport keys: If an ASK was produced at the end of a Noise handshake, right before ‘Split()’ is called, then the ASK has equivalent or stronger ‘indistinguishable from random’ properties to those of the transport keys.
- Transcript authentication: Message authentication codes (MACs) produced using an ASK authenticate the entire Noise handshake transcript up to the point that the ASK was created.
- Independence from the Noise chaining key: It is infeasible to recover any knowledge about the Noise chaining key from any number of ASKs.
- Independence from all other ASKs: It is infeasible to recover any knowledge about one ASK from any number of other ASKs.

Three different ASK labels are used to produce ASKs within ZSSP. “ASKK” is the label for producing two “key exchange keys”, which are used to authenticate key confirmations. “ASKR” is the label for producing the “ratchet key” and “ratchet fingerprint”, whose purpose will be described in Section 3. And “ASKH” is the label for two “header keys”, which will be described in Section 6.1.

2.4 Quantum Forward Secrecy

One major goal of ZSSP is to achieve quantum forward secret confidentiality and identity hiding. The best way we are aware of to achieve this is through an ephemeral public key exchange using post-quantum cryptography. However current post-quantum public key systems have large keys, are incompatible with the Noise protocol, and are not approved under FIPS. This essentially leaves us with only one option, to use a post-quantum public key exchange as hybrid encryption on top of a FIPS approved public key exchange.

We chose to do hybrid encryption with Kyber1024, a post-quantum key encapsulation mechanism (KEM) [8]. In a Kyber1024 key exchange, the first message from Alice is a public key, and Bob’s response is a random symmetric key encrypted under Alice’s public key. To accomplish forward secrecy, we want this exchange to be ephemeral, as in Alice will destroy her private key once they have Bob’s symmetric key.

The Noise protocol has an unofficial extension for performing hybrid forward secrecy [15]. This was exactly perfect for our requirements, and so ZSSP directly implements this extension with Kyber1024 as the KEM functions.

3 Rekeying and Ratcheting

The threat model of ZSSP includes attackers who occasionally gain access to secret keys of Alice or Bob’s through some side channel. This happens all the time in real world crypto systems, either due to human factors, malware or a zero-day vulnerability. What we want is if an attacker gains one time access to the memory of Alice or Bob, as many of the security properties of Noise are either unaffected or are automatically “healed” as possible. We specifically want this healing to occur automatically to remove human error from

the protocol. Alice or Bob should not even have to be aware that they have been compromised for an attacker to be thwarted.

We also include in our threat model attackers who are recording every single communication that occurs between Alice and Bob. This is why forward secrecy is a necessity within the design of ZSSP. We want as few of the attacker’s recorded messages to be decryptable as practical in the event any secret key from Alice or Bob is stolen.

These design requirements make a rekeying protocol that automatically replaces the transport keys of both peers periodically a clear choice. In addition, the most straightforward way we can see to heal the security properties of Noise post-compromise is to perform an independent Noise handshake as the rekeying protocol.

This left one major problem to solve in regards to post-compromise rekeying: How do we prevent compromise-and-impersonate attacks, or worse, Man-in-the-Middle (MitM) attacks? The core problem is that Noise, without extensions, bases authentication entirely upon ownership of static private keys. If an attacker acquires one peer’s static private key, they can trivially impersonate them within any Noise handshake. If an attacker acquires both private keys, they can perform a MitM attack, where they are able to decrypt everything sent between both peers, and such an attack would be impossible for either peer to detect.

Our solution takes heavy inspiration from the double ratchet algorithm [3] one of the first proposed solutions to this problem. The idea is to essentially chain together all rekey handshakes using a KDF as a one-way “ratchet”. If done correctly, then authentication for every key exchange is based not only on knowledge of a peer’s static private key, but also knowledge of a symmetric “ratchet key”, which both peers are constantly rotating. This is inherently a stateful algorithm, both peers will have to securely store their ratchet key in a persistent storage device. Indeed, it has been proven that post-compromise security cannot be achieved with a stateless algorithm [4].

3.1 Noise KK

In ZSSP, Alice and Bob rekey using Noise KKpsk0. This is a variant of Noise that assumes Alice and Bob have preshared public keys, and some preshared symmetric key (PSK). Within our implementation of Noise KKpsk0, we again replace HKDF with KBKDF. However we do not perform hybrid encryption with Kyber1024. Instead, to “carry forward” the quantum-forward secrecy properties of our initial Noise XK handshake, and to achieve post-compromise security, we derive a “ratchet key” ASK from the previous Noise handshake. It is this ratchet key that is used as Alice and Bob’s PSK in both Noise KK and Noise XK.

The full Noise protocol name is

`Noise_KKpsk0_P384_AESGCM_SHA512.`

Furthermore, all Noise KKpsk0 rekeying packets are AEAD encrypted under the key exchange key ASK obtained from the previous handshake. So handshake packets are double encrypted, first under Noise KKpsk0, and a second time under the previous Noise handshake. This upgrades the security properties of the Noise KKpsk0 handshake messages with the security properties of a fully established Noise session. This dramatically reduces the attack surface area of our rekeying protocol, by making it infeasible to take advantage of the reduced security properties of Noise KKpsk0 handshake messages. Double encryption was primarily added to the protocol to protect against a large variety of denial of service (DOS) attacks (primarily session truncation attacks). If ZSSP did not have DOS resistance as a primary design goal, it is likely we could have gotten away with not double encrypting rekeying packets.

3.2 Trigger for Rekeying

Since ZSSP is a real-time protocol, rekeying in ZSSP is primarily triggered by a 1 hour timer running on each peer’s local machine. Each timer is locally randomized by subtracting a 10 minute “jitter” that prevents rekeying events from occurring predictably on the hour. If, however, Alice and Bob are exchanging huge amounts of data there is a backup trigger. If the same transport key is used 2^{30} times, the encrypting peer will initiate rekeying. This mitigates the weakening security of AES-GCM when the same key is reused billions of times.

NIST has a requirement that an AES-GCM key must not be reused over 2^{32} times. For this reason we also require if either Bob or Alice encrypts with the same transport key $2^{32} - 1$ times, they will immediately terminate their session. This is extremely unlikely to occur in practice because it requires one party to encrypt $2^{32} - 2^{30} - 1$ packets before the session finishes rekeying, which can take at most two minutes. The session is far, far more likely to successfully rekey before then.

3.3 Ratchet Key Management

ZSSP allows for a decent amount of configuration surrounding how peers must manage and authenticate ratchet keys. This is precisely because ratchet keys require reliable persistent storage, which may not be available on some platforms. This allows the application to decide how to tradeoff security for usability and portability. The full configuration space consists of 4 security flags which are described in [Section 4.4](#). In this section however, we will be simplifying the configuration space of ZSSP to just 2 modes of operation.

If we enable all security features, we get *Persistent Mode* ZSSP. This mode of operation has state of the art post-compromise resistance properties, but as a consequence, if a user loses or corrupts their storage device they will no longer be able to communicate, and will have to reauthenticate to all of their peers to reset their ratchet keys.

If we disable all security features, we get *Opportunistic Mode* ZSSP. This mode of operation will warn the user if it detects a peer may have been compromised, but will not enforce a zero-communication policy. This makes it inherently vulnerable to post-compromise attacks. We still consider this a novel security property for real-time protocols, since it makes undetectable MitM extremely difficult to achieve, even with a full compromise of both communicating peers. In this mode ZSSP can gracefully coordinate resetting two peers' ratchet keys to zero in the event one peer has corrupted their keys, without any additional round trips. This allows a peer that does not have writeable or reliable persistent storage to still be able to use ZSSP. A persistent mode peer can communicate directly with an opportunistic mode peer, without performing any kind of negotiation to do so.

[Table 1](#) contains a brief summary of the security properties each of these modes of operation has. Below is a glossary defining each of these security properties, as they relate to ZSSP.

- Perfect Forward Secrecy – An attacker with the static private keys of two peers cannot decrypt recordings of messages sent between them.
- Forward Secret Identity Hiding – The identities of peers are always either not transmitted or are encrypted with forward secrecy to an authenticated peer. An attacker cannot test candidate static public keys without the corresponding private key.
- Quantum Forward Secrecy – A quantum computer powerful enough to break elliptic-curve cryptography is not sufficient to decrypt recordings of messages sent between peers.

- Ratcheted Forward Secrecy – In order to break forward secrecy an attacker must record and break every single key exchange two peers perform, in order, starting from the first key exchange that uses a ratchet key the attacker has access to. This, among other things, improves forward secrecy under a weak or compromised random number generator.
- Silence is Golden – A peer will not respond to any anonymous, inauthentic or replayed message.
- Key-Compromise Impersonation – The attacker has the static private keys of two peers, and attempts to impersonate some other peer to them.
- Compromise-and-Impersonate – The attacker has the static private keys of a single peer, and attempts to impersonate them to any other peer.
- Single Key-Compromise MitM – The attacker has the static private keys of a single peer, and attempts to become a Man-in-the-Middle between them and any other peer.
- Double Key-Compromise MitM – The attacker has the static private keys of two peers, and attempts to become a Man-in-the-Middle between them.

Opportunistic mode ZSSP is vulnerable to Compromise-and-Impersonate and Double Key-Compromise MitM because an attacker can perform a downgrade attack to reset one or both peer's ratchet keys to zero. However because such a downgrade should not normally happen between honest peers, if one does occur we can warn the user it has occurred, allowing them to investigate out-of-band whether them or their peer has corrupted or lost their persistent storage. If both peers have not corrupted their persistent storage a downgrade attack has almost certainly occurred, and one or more static keys are compromised.

Compromise-and-Impersonate and Double Key-Compromise MitM attacks are possible against persistent mode ZSSP for a brief window of time. When an attacker compromises a peer, and steals their ratchet keys along with their static private keys, they have a limited time during which they can perform an impersonation attack. Otherwise the peer will engage in new key exchanges and rotate out the compromised ratchet keys. Furthermore, if the attacker commits to an impersonation attack, this will permanently desynchronize the compromised peer's ratchet keys from the peer being impersonated to. If the attacker does not commit to becoming a permanent MitM from that point onwards, their impersonation attack will be detected.

For peers actively communicating with each other, the attacker's window of opportunity is at most an hour. For peers not actively communicating, the attacker has until those peers contact each other again.

3.4 The Ratchet Fingerprint

Every time Alice and Bob complete a key exchange, either to initiate a new session (Noise XK) or to rekey an existing session (Noise KK), they will both derive a new ratchet key. Upon initiating a new key exchange, Alice and Bob will need a protocol to agree upon which previously derived ratchet key they will use as the PSK. The most straightforward solution is for Alice and Bob to simply always use the most recently derived ratchet key as the PSK. This is the protocol Alice and Bob use for rekeying a session. However an issue arises with this protocol if it is used for session initiation. Due to the two generals problem, there is no way for Alice and Bob to coordinate deriving the new ratchet key at the exact same time. As a result, if one peer disappears during key exchange, the two peers may disagree from then onwards what the most recently derived ratchet key is.

Worst still, an attacker could intentionally drop network packets to cause a peer to disappear. This could allow an attacker to permanently prevent Alice and Bob from communicating. This is a protocol-level denial of service (DOS) attack. The threat model of ZSSP includes attackers whose sole goal is to prevent Alice and Bob from communicating, and while that cannot be prevented in its entirety, our design goal is to make every form of DOS attack against ZSSP more difficult or expensive than a volumetric DDOS attack.

So Alice and Bob will need to allow potentially the last two derived ratchet keys to be used to initiate a new session. To accomplish this, Alice and Bob derive a *ratchet fingerprint* ASK at the same time as the ratchet key ASK. The ratchet fingerprint is used to cryptographically identify the ratchet key. Alice will attach it as the payload of their first message to Bob, which will allow Bob to lookup the corresponding ratchet key to use as the PSK. This guarantees both peers use the same ratchet key as the PSK.

To minimize the number of ratchet keys Alice and Bob have to store in memory, the final step of every key exchange in ZSSP is to delete the previous ratchet key, once both peers are certain the other peer has derived the new one. So usually Alice and Bob will only have and use the most recently derived ratchet key, but if a peer disappears during key exchange, Alice and Bob will have up to the last two ratchet keys, and will be able to coordinate using the one they are certain both peers have access to.

If this is the first time Alice and Bob are communicating, Alice will send a string of all zeros instead of a ratchet fingerprint to signal this fact. Both Alice and Bob understand this to mean they ought to complete the key exchange with a ratchet key of all zeros. When Alice reveals their identity in the third message of Noise XK, Bob will have to check that it is indeed true that Alice has never communicated with Bob before, and they don't already have a ratchet key and fingerprint. Similarly, if Alice does use a valid ratchet fingerprint and key, Bob must check if the pair is actually associated with Alice, and isn't being stolen from a different peer.

Since the ratchet fingerprint is included in the first message of Noise XK, with weak forward secrecy, there is some concern it could violate identity hiding. However, since the ratchet fingerprint is a constantly rotating ASK, information about the communicating peers can only be leaked by it if the same ratchet fingerprint is used twice. In normal operation, not only will the ratchet fingerprint only be used once, but it will be deleted with the ratchet key when the key exchange is completed, providing replay protection. Furthermore, if the same ratchet fingerprint is used more than once, all this will reveal is that the same pair of peers are initiating a session with each other, and only if Bob's private key is compromised.

Actually this protocol gives ZSSP a lot of useful properties. For one thing Bob can require Alice to include a recognized, non-zero ratchet fingerprint in their first message. This is how ZSSP can achieve "Silence is Golden" despite the fact that the first Noise XK packet is usually anonymous and replayable. It also allows Bob to authenticate Alice's identity immediately, as opposed to waiting for Alice's next message. This protocol also is integral to how Alice and Bob are able to coordinate the ratchet key management described in [Section 3.3](#) without any additional round trips.

If Alice has corrupted their storage, Alice can either send zeros or send whatever corrupted ratchet fingerprint they still have to Bob. If Bob sees zeros instead of a ratchet fingerprint, and Bob is in opportunistic mode, Bob completes the key exchange with the zero ratchet key, making it possible for Alice to connect. If Alice sent a corrupted ratchet fingerprint, or Bob is the one who corrupted their storage, and if Bob is in opportunistic mode, Bob will ignore the unrecognized ratchet fingerprint and instead uses the zero ratchet key as the PSK. When Alice receives Bob's reply, if Alice is in opportunistic mode, Alice will decrypt Bob's reply with both the ratchet key they intended to use and the zero ratchet key, and go with the one that successfully decrypts the reply. This allows Alice and Bob to reset their ratchet keys in such a way that an attacker cannot perform a downgrade attack without at least one peer's static private key. And if Alice and Bob are in persistent mode, a downgrade attack is simply not possible.

4 Zeta Key Exchange

ZSSP is a stack of three closely related, but independent protocols. These are the *Zeta Key Exchange* (ZKE), the *ZeroTier Challenge Protocol* (ZCP) and the *ZeroTier Fragmentation Protocol* (ZFP), described in [Figure 1](#). The Zeta Key Exchange is the most complex and most essential from this stack: It is the part of ZSSP that implements Noise XK and Noise KK and directly interfaces with the upper protocol. For that reason we are going to describe it first, in isolation from the lower protocols.

Figure 1: The protocol stack of ZSSP. When the upper protocol sends a packet, it must pass down the protocol stack from the top to the bottom, where each layer may modify or adds to the packet in some way. When the datagram protocol receives a packet, it passes it up towards the top of the protocol stack. Any layer may consume the incoming packet and not pass it upwards. ZKE performs key exchanges to provide authenticated encryption to packets. ZCP protects any key exchange protocol above it from CPU exhaustion DOS attacks. And ZFP fragments packets to fit within the MTU of the protocol below it, using an algorithm that mitigates common fragmentation DOS attacks.

Upper Protocol
Zeta Key Exchange (ZKE)
ZeroTier Challenge Protocol (ZCP)
ZeroTier Fragmentation Protocol (ZFP)
Datagram Protocol (usually UDP)

The next section will be dedicated to describing ZKE in explicit detail. We will be making heavy use of common mathematical notions and notation surrounding Deterministic Finite Automata, State Machines and AKE security. The goal with this section is to describe ZKE at a level of detail necessary both to allow someone to implement ZKE, and to aide future mathematical analysis of ZKE.

Definition 1 (H). [ZKE packet types] We define 8 different packet types that are essential for the functioning of ZKE.

- X_1 : This packet type contains the first message of Noise XK. It is identified internally with packet type number '0'.
- X_2 : This packet type contains the second message of Noise XK. It is identified internally with packet type number '1'.
- X_3 : This packet type contains the third message of Noise XK. It is identified internally with the number packet type number '2'.
- C_1 : This packet type confirms that the remote party has completed the Noise handshake. It is identified internally with packet type number '3'.
- C_2 : This packet type acknowledges that packet type C_1 has been received, so the remote peer can stop resending packet C_1 . It is identified internally with packet type number '4'.
- K_1 : This packet type contains the first message of Noise KK. It is identified internally with packet type number '5'.
- K_2 : This packet type contains the second message of Noise KK. It is identified internally with packet type number '6'.

In addition, there are 3 packet types which the upper protocol can cause to be sent, but are non-essential to the protocol. These will not be sent unless the upper protocol explicitly calls for them to be sent.

- D : This packet type confirms that Bob has completed the Noise handshake, but is refusing to connect to Alice. It is identified internally with packet type number '7'.
- P : This packet type contains a payload of data for the upper protocol to send and receive. It is identified internally with packet type number '8'.

Figure 2: Handshake Hello X_1 – This is the packet structure of the first packet Alice sends to Bob. It conforms to the message structure required by the Noise protocol.

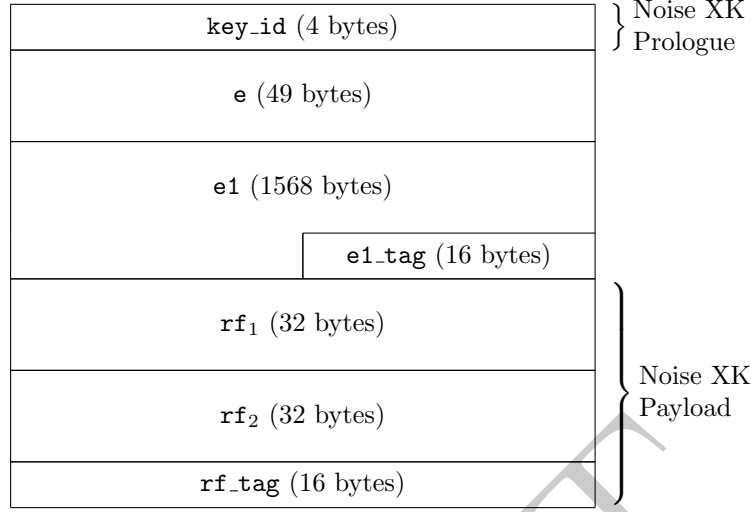


Figure 3: Handshake Response X_2 – Bob sends this packet in response to Alice’s Hello packet. It also conforms to the message structure of the Noise protocol. All packets in ZKE do.

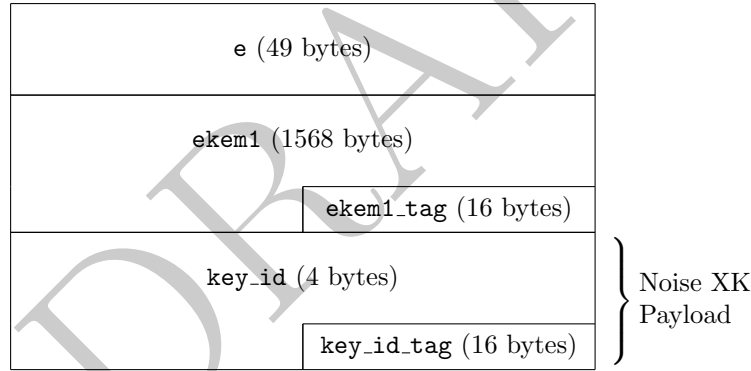


Figure 4: Handshake Completion X_3 – This is the packet structure of the final message of Noise XK, which Alice sends to Bob.




Figure 5: Key Confirmation C_1 , Acknowledgement C_2 , and Session Rejection D – These three packet types have the same packet structure. They just contain a MAC to confirm both peers have completed the handshake.

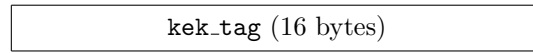


Figure 6: Rekey Initiation K_1 , and Rekey Completion K_2 – Both types of Noise KK rekeying packets have the same structure.

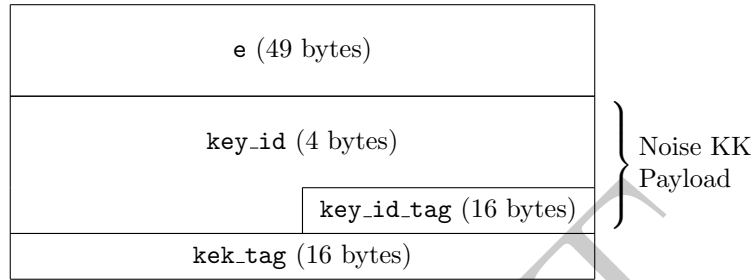


Figure 7: Data Transport Packet P – This is the structure of packets containing payloads of data from the upper protocol.

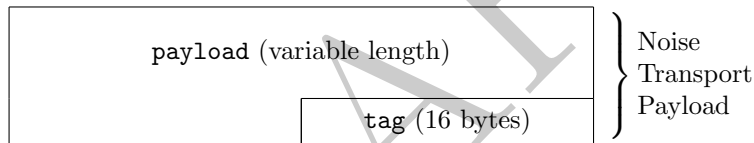
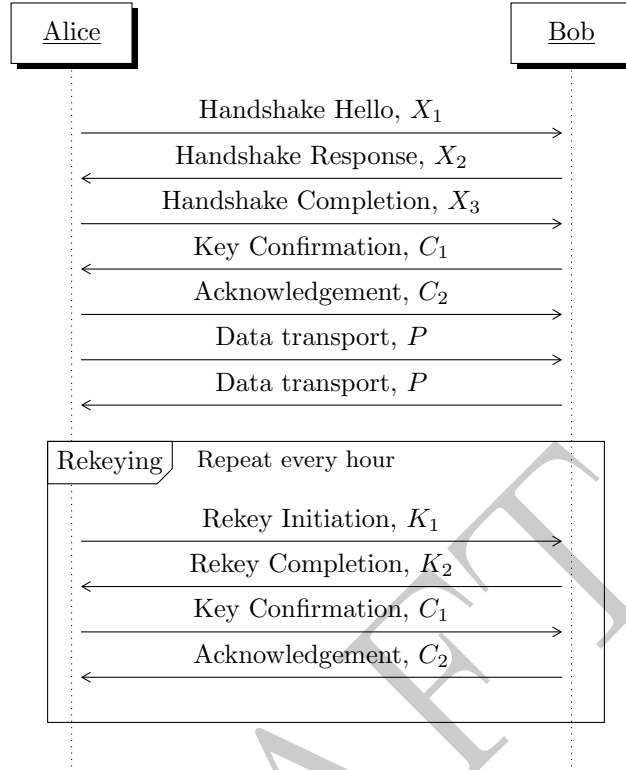


Figure 8: The Zeta Key Exchange in ideal conditions.



4.1 Zeta State Machine

We model ZKE as two state machines in communication with each other. Each machine will send or resend packets to the remote party based on which state it is in, will only transition state in response to receiving a particular type of packet from the remote party, and will only modify important cryptographic variables during an atomic transition from one state to the next.

At the end of this section we will have defined ζ , which is the high-level state machine that represents both Alice and Bob's side of ZKE.

Definition 2 (H). [ZKE Automata] We will first start by defining Deterministic Finite Automata (DFA) β , which will be the foundation upon which we construct the ZKE state machine. β is depicted in [Figure 9](#).

Let $Q = \{\perp, A_1, B_2, A_3, S_1, S_2, R_1, R_2\}$ be the set of possible states within β .

Let $\Sigma = \{X_1, X_2, X_3, K_1, K_2, C_1, C_2, D, \tau, \chi\}$ be the alphabet of packet types β can send and receive, as well as special symbols τ and χ .

τ is not a packet type, but rather a representation of a transition being triggered by a state “timing out”. All states besides \perp in ZKE have a timeout timer that begins when the state is entered, and if the machine does not transition state, the timer will go off and trigger some state transition.

χ represents the event that the actual computer process running ZKE is restarted. For completeness' sake we need to account for all possible times at which ZKE could restart and lose all volatile memory. We have designed ZKE to have the property that it can always gracefully recover from a sudden restart.

Let $\delta : Q \times \Sigma \rightarrow Q$ be the transition function. δ has the following special transitions:

- $\delta(\perp, \tau) = A_1$.
- $\delta(\perp, X_1) = B_2$.
- $\delta(A_1, X_2) = A_3$.
- $\delta(A_1, \tau) = A_1$.
- $\delta(B_2, X_3) = S_1$.
- $\delta(B_2, \tau) = \perp$.
- $\delta(A_3, C_1) = S_2$.
- $\delta(A_3, D) = \perp$.
- $\delta(A_3, \tau) = A_1$.
- $\delta(S_1, C_2) = S_2$.
- $\delta(S_1, \tau) = \perp$.
- $\delta(S_2, \tau) = R_1$.

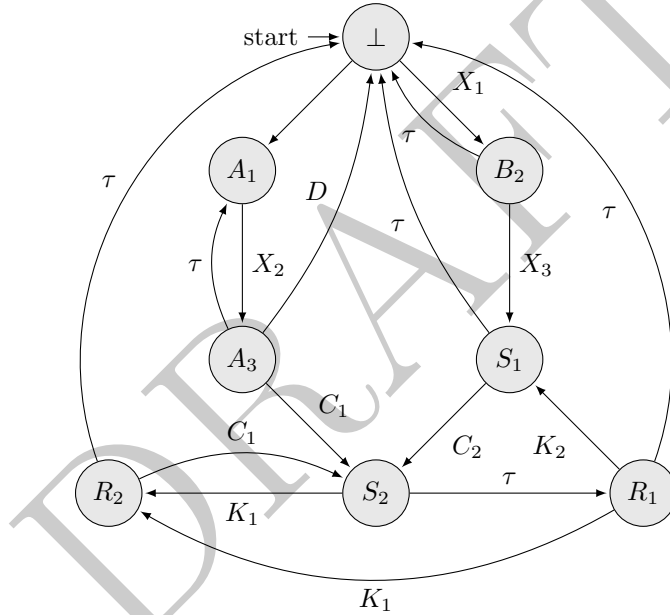
- $\delta(S_2, K_1) = R_2$.
- $\delta(R_1, K_2) = S_1$.
- $\delta(R_2, C_1) = R_2$.
- $\delta(R_1, K_1) = R_2$.
- $\delta(R_1, \tau) = \perp$.
- $\delta(R_2, \tau) = \perp$.

In addition, for all states $q \in Q$, $\delta(q, \chi) = \perp$, which in other words means that the process restart symbol, χ , transitions all states to the initial state, \perp . For all transitions of δ that are not yet specified, they are the identity transition, as in a transition that maps a state to itself.

β contains the transition $\delta(\perp, \tau) = A_1$, but it is important to note \perp , being the initial state, does not have any attached timer within ZKE, and will not be triggered automatically. This transition simply represents the upper protocol initiating a session through ZKE. Most upper protocols will attempt to restart sessions on a timer, which is why we chose to represent this unique transition with the τ symbol.

Let $\beta = (Q, \Sigma, \delta, \perp, \{S_2\})$ be the ZKE Automata.

Figure 9: The ZKE Automata, β – Both sides of a ZSSP session contain a copy of this machine. A_1 , B_2 and A_3 are Noise XK states, S_1 and S_2 are session established states, and R_1 and R_2 are Noise KK states. Each symbol represents a received packet type, except for τ which represents a timeout transition. Omitted are the identity and χ transitions.



Definition 3 (H). [The Zeta State Machine, ζ] We are going to extend β with behaviors and rules that cannot be modelled adequately by DFAs. This new, extended machine will be referred to as ζ , the Zeta state machine. ζ will retain the core states, alphabet, transition function and initial state as β , but we are going to add the ability for ζ to establish a session, send a remote peer encrypted packets, and to process incoming packets.

\perp is treated as a unique, nondeterministic state within ζ . Internally, ζ is always in the \perp state. Whenever an input is received that would cause a transition out of the \perp state, ζ will stay in the \perp state, but spawn a copy of itself that is initialized to the correct transition state, either A_1 or B_2 . If this new instance of ζ enters the \perp state, it will be deleted from memory. The original ζ will still exist in the \perp state, ready to spawn more copies. This is directly analogous to a nondeterministic transition within an NFA. This is how ZKE handles multiple session to a single peer, each session can be considered its own independent instance of the ζ state machine, running concurrently with each other. If we are only interested in considering one session to one peer, we can safely ignore this rule.

When ζ is in a particular state, it chooses specific packet types from the alphabet to send to the remote peer. The remote peer will also be represented by a separately running instance of ζ . When a peer successfully

receives a packet, it feeds as input to ζ and possibly trigger a transition of state. Below is the list of what packet ζ sends based on which state it is in.

- When entering state A_1 , packet X_1 is created and sent.
- When entering state B_2 , packet B_2 is created and sent.
- When entering state A_3 , packet X_3 is created and sent.
- When entering state S_1 , packet D or C_1 is created and sent.
- In state S_2 , no packet is sent.
- When entering state R_1 , packet K_1 is created and sent.
- When entering state R_2 , packet K_2 is created and sent.

Section 4.3 discusses how these packets are structured, and what algorithms are used to create and process each packet.

ζ has a timer system to automatically and locally trigger state transitions or packet resends. This system exists primarily as a solution to the “two generals problem”. Since ZKE assumes an out-of-order, lossy transport environment it is necessary to have a system of resending lost messages and timing out those resends, similar to TCP. The ZKE timer system is designed to be lightweight, security focused, and simple. It provides strong guarantees about the maximum amount of time that may pass until certain security critical events, such as completing a handshake or ratcheting a session key, must occur.

We assume that the underlying computer running ζ exposes some mechanism for creating a *timer* which can be *set* to some amount of time, and the computer will *trigger* the timer after approximately that amount of real time has passed.

- ζ runs a single timeout timer that starts whenever any state other than \perp is entered. If any state transition occurs this timer is reset to a new amount of time. If this timer is triggered before a state transition occurs, ζ gives τ as input to β . The timeout timer must never be reset or modified outside of a state transition.
- States A_1 , B_2 and A_3 always set their timeout timer to 10 seconds.
- States S_1 , R_1 and R_2 always set their timeout timer to 1 minute.
- State S_2 sets its timeout timer to a uniform random number in the range 50 minutes to 1 hour. This amount of time is randomly generated each time ζ enters state S_2 .
- In states A_1 , A_3 , S_1 , R_1 and R_2 , ζ runs an additional “resend timer”. Whenever this timer triggers, a copy of the respective packet that this state generated is sent, and the resend timer is reset. Packets C_1 , K_1 and K_2 are re-encrypted under the key exchange key kek , and a fresh encryption counter. States B_2 and S_2 do not have a resend timer and do not resend packets. The resend timer is always set to 1 second.
- Any state may trigger timeout early for any reason. In particular it is recommended to timeout state B_2 early if memory is being filled with unfinished handshakes. This prevents memory exhaustion attacks.

The timer system has the property that all timers are generated locally, checked locally, and are never sent “over the wire”. This has the advantage of making it difficult to impossible for a remote attacker to manipulate a peer’s timers. The system has also been intentionally designed to make it impossible for ζ to ever get indefinitely stuck in one state. If it could, it would open up the possibility that an attacker could intentionally cause this to happen, which would be a form of a DOS attack. The rekeying timer for state S_1 is randomized to deter traffic analysis of ZSSP, and to prevent peers from simultaneously entering state R_1 , which would be redundant and inefficient.

It is important to note from this definition that there is no such thing as a “heartbeat” in ZKE, nor ZSSP as a whole. ZKE, on its own, does not require “keep-alive” messages to be periodically sent between peers.

Instead, the only packets ZKE will automatically send are those which are strictly necessary to maintain strong forward secrecy. This makes ZKE ideal for applications where a silent protocol is preferred. It is up to the upper protocol to implement a heartbeat or keep-alive system if it is deemed necessary.

ζ , being a cryptographic protocol, also has many rules relating to how it must cryptographically process incoming or outgoing packets, and how those packets can influence state transitions of β . Below is a numbered list of all of these rules.

1. Several transitions within β have a corresponding algorithm ζ computes. These are described in [Section 4.3](#). When a transition begins, ζ computes the corresponding algorithm, and it only allows β to transition state if all authentication steps within this algorithm succeed.
2. If authentication fails specifically during the execution of the Noise XK or Noise KK handshake, this must immediately trigger timeout, τ . Any other form of authentication failure will cause the corresponding packet to be ignored, as if it had never been received.
3. When transition $\delta(A_1, \tau) = A_1$ or $\delta(A_3, \tau) = A_1$ occurs, ζ generates a new X_1 packet, and does not reuse the previous X_1 packet.
4. The transition, $\delta(R_1, K_1) = R_2$, is only allowed to occur if ζ acted as Bob, the responder, in the initial Noise XK handshake (i.e. if ζ has previously been in the B_2 state).
5. If ζ receives a valid C_1 packet while in state S_1 , S_2 , R_1 or R_2 , ζ will reply with a new C_2 packet encrypted under the most recently created key exchange key, \mathbf{kek} .
6. ζ may only send data transport packets on behalf of the upper protocol when in states S_1 , S_2 , R_1 and R_2 . Note that this implies a peer may receive data transport packets in states A_3 , S_1 , S_2 , R_1 and R_2 .
7. If 2^{30} or more data transport packets are sent using the same transport key, and ζ is in state S_2 , then timeout is triggered early. If $2^{32} - 1$ data transport packets are sent using the same transport key then β receives as input symbol χ , which is to say it immediately transitions to state \perp and ends the session.

It is not immediately clear why some of the rules in the above list exist, nor what function they might serve in the protocol. For that reason, below is a list of explanations for each processing rule. They are numbered by which rule they are explaining, respectively. Some of these explanation are discussed in further detail in other sections.

1. This rule should be fairly self explanatory, in order to provide security ZKE must do authenticated encryption, particularly the authenticated encryption required by the Noise protocol.
2. This is to conform to the Noise protocol's requirement that the handshake be aborted in the event either peer fails authentication during the handshake. Other than that we want to obey the security principle that inauthentic packets should not trigger any change in state.
3. This rule serves a few functions. First and foremost it guarantees that when a handshake is unsuccessful for whatever reason, both Alice and Bob will generate new ephemeral keys. This prevents identical key material from being derived, reducing the risk of catastrophic key reuse. Due to the timer system, this also imposes a strict time limit upon any MitM attack that relies upon intercepting Alice's initial packet. Secondly, regenerating the X_1 packet also regenerates a special nonce value that is used by the ZeroTier Fragmentation Protocol to provide DOS protection.
4. This is to ensure only one peer can enter state R_2 at a time, guaranteeing the other peer stays in state R_1 . Essentially this rule makes it impossible for both peers to act as Bob at the same time in a Noise KK handshake, which would lock-up a session if it were allowed to happen.
5. The remote peer will continue to resend C_1 packets until it receives a C_2 packet. Since C_2 packets are not resent, they have to be sent as an acknowledgement packet to every received C_1 packet. Otherwise the remote peer might never transition to state S_2 .

6. Data transport clearly cannot occur in states \perp , A_1 and B_2 , because no Noise key has been established. Alice does obtain a Noise key when they enter state A_3 . However, for reliability, we want to give Bob an opportunity to refuse connection with Alice based on their static key and identity, and we want to make sure out of order data will be decryptable by Bob. For the sake of improved forward secrecy, we also want to make sure both parties have confirmed a new ratchet fingerprint and ratchet key before they begin communicating. Otherwise, by preventing Bob from ever receiving packet X_3 , an attacker can cause Alice and Bob to always use the same ratchet key.
7. This is to conform with NIST's requirement that an AES-GCM key never be used more than 2^{32} times. It also avoids AES-GCM's weakening security when a large volume of data is encrypted.

4.2 Background

The following are the 4 cryptographic primitives ZKE is based upon. We will be abbreviating these algorithms with generic notation in the sections that follow, notation that is defined here.

Definition 4 (H). [SHA-512 [7]] Let $\text{HASH}(M)$ be the SHA-512 hashing algorithm, where M is the string input to be hashed. It has a 512-bit output.

Definition 5 (H). [KBKDF [12]] Let $\text{KDF}(K_{IN}, \text{Label}, \text{Context}, N)$ be the KBKDF key derivation algorithm, instantiated in HMAC-Counter mode using SHA-512. Variable K_{IN} is the input key material, Label is some static string, Context is additional input key material, and N is the number of 512-bit outputs to be produced. $\text{KDF}(K_{IN}, \text{Label}, \text{Context}, N)$ produces as output (x_1, \dots, x_N) , a tuple of N 512-bit outputs.

Given $i \in \{1, \dots, N\}$, we will use the notation $\text{KDF}(K_{IN}, \text{Label}, \text{Context}, N)_i$ to refer to the i th output of KDF. When assigning a 512-bit output to a variable or field that is 256-bits in size, it is assumed that the output is being truncated to just the first 256-bits.

So $k \leftarrow \text{KDF}(x, l, y, 3)_2$ represents computing KBKDF on inputs $K_{IN} = x$, $\text{Label} = l$, $\text{Context} = y$ and $L = 3 \cdot 512$, and setting variable k equal to bits 512 to 1023 of the output. If k is a variable of size 256-bits, then k is set equal to bits 512 to 767 of the output.

Definition 6 (H). [AES-GCM [6]] Let $\text{AEAD}(K, N, H, M)$ be the AES-GCM Authenticated Encryption with Additional Data algorithm, where K is the encryption key, N is the AEAD nonce, H is the additional authentication data, and M is the plaintext message to be encrypted. $\text{AEAD}(K, N, H, M)$ produces as output $c||t$, a ciphertext, c , concatenated with its 128-bit (16 byte) authentication tag, t .

Definition 7 (H). [P384 [5]] Let $\text{DH-Gen}()$ be the P384 elliptic curve Diffie-Helman key generation algorithm. $\text{DH-Gen}()$ outputs a random keypair, (x, g^x) , where x is the private key and g^x is the public key. g is the generator of the P384 elliptic curve group.

Given (x, g^x) and (y, g^y) , two output keypairs from $\text{DH-Gen}()$, a *key agreement* between these keys can be performed by computing $(g^x)^y$ or $(g^y)^x$. It is the case that $(g^x)^y = (g^y)^x = g^{xy}$. This value, g^{xy} , is considered the output key material of Diffie-Helman key agreement.

Definition 8 (H). [Kyber1024 [8]] Let $(\text{KEM-Gen}, \text{KEM-Enc}, \text{KEM-Dec})$ be the Kyber1024 key encapsulation mechanism. $\text{KEM-Gen}()$ randomly generates a keypair, (e_{priv}, e_{pub}) , where e_{priv} is the private key and e_{pub} is the public key. $\text{KEM-Enc}(e_{pub})$ takes as input a Kyber1024 public key, and outputs the pair (e_{key}, e_{kem}) , where e_{key} is the symmetric key and e_{kem} is the encapsulated ciphertext of e_{key} . $\text{KEM-Dec}(e_{priv}, e_{kem})$ takes as input a private key and an encapsulated ciphertext, and outputs e_{key} , the decryption of e_{kem} . Both KEM-Enc and KEM-Dec can output \perp , the null value, which implies authentication failure due to invalid input keys.

In addition, it is important to be familiar with common notation for cryptographic pseudocode. The symbol \perp represents the null value. When a variable is set to \perp , it means whatever was previous stored within the variable is being permanently deleted from memory. All pseudocode variables are initialized to \perp unless otherwise stated. The symbol ε is the empty string, an array of zero length. Given some integer n , 0^n represents the bit-string of length n that is all zeros. So $0^8 = \text{"00000000"}$. The binary operator $||$ is string concatenation.

4.3 Transition Algorithms

With the necessary background established, we can now define the final component of the Zeta state machine, the state transition algorithms. Anyone looking to implement the Zeta state machine must read this section in its entirety. Many paragraphs contain rules not represented within the diagrams or algorithm pseudocode. Each rule qualified with *must* must be implemented.

As is described in [Definition 3](#), each state transition within ζ has a corresponding algorithm. These algorithms *must* be computed atomically with the state transition. If the algorithm fails or aborts, then the corresponding state transition *must* not occur. All of these algorithms are described in this section. They have access to a collection of global variables, defined below.

- Persistent ratchet keys $\mathbf{rk}_1, \mathbf{rk}_2$, to be used as a handshake PSK
- Persistent ratchet fingerprints $\mathbf{rf}_1, \mathbf{rf}_2$, to identify a particular ratchet key
- Long term static keypairs (u, g^u) and (v, g^v)
- Short term randomized key identifiers $\mathbf{kid}_1^i, \mathbf{kid}_2^i$, to be used for multiplexing between multiple peers
- Short term key exchange keys $\mathbf{kek}_1^i, \mathbf{kek}_2^i$, for authenticating key confirmations and rekeying
- Short term Noise transport keys $\mathbf{nk}_1^i, \mathbf{nk}_2^i$, for AEAD encryption of data transport packets
- Short term header keys $\mathbf{hk}_1, \mathbf{hk}_2$, to be used by the ZeroTier fragmentation protocol
- Ephemeral keypairs (x, g^x) and (y, g^y)
- Ephemeral key encapsulation variables $e_{priv}, e_{pub}, e_{key}$ and e_{kem}
- Ephemeral Noise chaining keys, c and c'
- Ephemeral Noise encryption keys, k and k'
- Ephemeral Noise handshake hashes, h and h'
- Temporary ratchet key and fingerprint \mathbf{rk}' and \mathbf{rf}' , used so Bob can complete Noise XK before knowing Alice's identity.
- Role identifier \mathbf{r} , used so peers are aware whether they were Alice or Bob in Noise XK
- Confirmed key index \mathbf{i} , used so peers know the most recently confirmed Noise key.

All of these variables, except \mathbf{rk} and \mathbf{rf} , are independent *per instance* of ζ . So each instance of ζ stores a unique and independent set of these variables, and they are never shared between separate instances of ζ .

Variables \mathbf{rk} and \mathbf{rf} are stored on a persistent storage device, and can be accessed by multiple instances of ζ over time. Implementations *must* guarantee each instance of persistent variables \mathbf{rk} and \mathbf{rf} is associated with a single, unique remote peer. When implementing ζ , each instance of ζ *must* store a local copy of \mathbf{rf} . Writes to \mathbf{rk} and \mathbf{rf} *must* be batched together as one atomic operation. Implementations *must* check that the local copy of \mathbf{rf} is consistent with \mathbf{rf} prior to every write. If they are inconsistent, then the entire write *must* be cancelled, and ζ *must* immediately abort the transition algorithm which triggered the write. Then, ζ *must* be deleted (i.e. ζ *must* perform the timeout transition, τ). This policy guarantees that if multiple, concurrent instances of ζ exist for the same remote peer, only one of them will be allowed to write to \mathbf{rk} and \mathbf{rf} , while the others will be deleted.

It *must* be infeasible to recover a non-zero value of \mathbf{rk} or \mathbf{rf} based on the amount of time read and write operations on \mathbf{rk} or \mathbf{rf} take. To this end, implementations must not directly operate on ratchet keys (check for equality, create a search index, etc.). Instead, these operations must be performed indirectly upon their ratchet fingerprints. This is to ensure that, in the event a side-channel attack is found, only the ratchet fingerprint can be leaked.

What constitutes a “single, unique remote peer” is up to the upper protocol to decide. Usually remote peers are identified and differentiated by their static public keys (g^u or g^v). However ZKE does not strictly enforce a one-to-one relationship between static public keys and identity specifically so the upper protocol is able to rotate the static public keys of peers. There *must* be a well-defined equality relation between peers.

Definition 9 (H). [Session Counter] Every instance of ζ contains a single monotonically increasing counter, that is initialized to 0. We will use the notation $\text{Count}()$ to represent incrementing this counter by 1 and returning the previous counter value.

So the very first call to $\text{Count}()$ within ζ will return 0, the second call will return 1, and so on.

It is assumed that that output of $\text{Count}()$, the counter value, will be used as an AES-GCM nonce. When a remote peer decrypts an AES-GCM ciphertext that uses a counter value nonce, they *must* first statefully check that this counter has never been received before, and fail authentication if it has been replayed.

ZKE uses a 64-bit (8 byte) counter, but AES-GCM uses a 96-bit (12 byte) nonce/IV. The Noise protocol does specify that, in order to use a counter value as an AES nonce, it should be encoded as a big-endian integer with 4 bytes of zero padding to the left of it. However, for good reason, we have decided to utilize the rightmost byte of that 4 byte padding to store the packet type number, as depicted in [Figure 10](#). This accomplishes two goals. First it explicitly authenticates the packet type of a packet, which makes it infeasible for an attacker to change the packet type field of a header without triggering an authentication failure. We could have used the additional authentication data parameter of AES-GCM to accomplish this, but the Noise protocol already makes extensive use of this parameter. Second, this nonce construction reduces the risk of catastrophic nonce reuse due to implementation error, specifically during key exchanges. While a correctly implemented counter would be sufficient for security, this adds an extra layer of defense. Given a packet type number p , and a counter value c , we will use the notation $p||c$ to represent this nonce construction.

Definition 10 (H). [Key Id Generation] **KID-Gen** is a stateful algorithm that outputs a locally unique, uniform random 32-bit string. The output of this algorithm will be used as the *key id* for a session key, allowing the local peer to multiplex many keys for many remote peers simultaneously. The output of $\text{KID-Gen}()$ *must* be locally unique from all other key ids currently in use. $\text{KID-Gen}()$ may only repeat an output if that output is currently not being used as a key id.

Definition 11 (H). [Persistent State] The variables **rk** and **rf** are considered the *persistent state* of ZKE. The values stored in these variables are not lost when a session ends, and can be *restored* at any time to initiate a new session.

rk is a tuple of up to two 256-bit *ratchet keys*. Similarly, **rf** is a tuple of up to two 256-bit *ratchet fingerprints*. Both **rk** and **rf** are initialized to $(0^{256}, \perp)$.

If two peers are in persistent mode, and wish to connect for the first time, they may use a preshared one time password, p , to do so. p *must* be a random string with at least 256-bits of entropy. If a one time password is being used then $r \leftarrow \text{KDF}(p, \text{"ZSSP_OTP_TO_RATCHET"}, \varepsilon, 2)$ *must* be computed. Both peers then initialize **rk** to (r_1, \perp) and **rf** to (r_2, \perp) . p *must* only be used once; A fresh instance of p *must* be generated for every new pair of peers who wish to connect.

It is assumed that prior to any usage of ZKE, Alice and Bob will generate their static keypairs with $\text{DH-Gen}()$. It is also assumed that Alice already knows Bob's public key, g^v , prior to any attempt to connect to Bob. Bob does not necessarily know Alice's public key.

Table 2: Intermediate Values of the Noise XKhs+psk2 and the Noise KKpsk0 Handshakes [1] [15] – (u, g^u) and (v, g^v) are respectively the static keypairs of Alice and Bob within *the current Noise handshake*, and the label $L = \text{"ZSSP"}$. The ciphertext of packets is hashed and not the plaintext. The following transition algorithms implicitly compute and have access to the values described here. This syntax for defining cryptographic variables comes from Benjamin Dowling et. al. [13]

We will not be going into detail how each packet is decrypted. All decryption within ZKE is either a straightforward implementation of Noise XK and Noise KK decryption, or otherwise a trivial application of AEAD decryption using AES-GCM. We will be assuming each packet is decrypted in-place, as in we will be reusing the local variable that referred to the encrypted packet to also refer to the decrypted packet.

If packet decryption fails because the AEAD MAC is inauthentic, this is considered authentication failure. Unless otherwise stated, if authentication fails all of the following algorithms immediately cease execution and returns an authentication failure error.

Prior to the execution of any of the following algorithms, ζ will check if it is in the correct state, if it is allowed to perform the related state transition, that the received key id matches the expected key id, and that the packet has the correct type number. If any of these checks fail execution is aborted and the packet is ignored.

Algorithm 1 Transition $\delta(\perp, \tau) = A_1$ – Alice creates and sends a “Hello” packet to initialize a session with Bob, **Figure 2**. Alice knows Bob’s static public key, g^v , prior to execution. By sending a Hello packet to Bob, Alice is implicitly trusting Bob.

The ratchet fingerprint, rf , is an ASK that does nothing more than uniquely identify the ratchet key it was derived with. This makes it possible for Bob to immediately identify Alice given just their Hello packet, if their Hello includes a ratchet fingerprint. Bob can configure ZKE to only reply to peers that have recognized ratchet fingerprints, thereby making ZKE entirely silent to everyone who does not have an authentic ratchet fingerprint. An attacker can record an authentic peer’s Hello packet and replay it, but Bob will only reply to this replayed packet for a short period of time, until that ratchet fingerprint is replaced. This is superior to Noise XK’s normal Hello packet security properties, which do not authenticate the sender and can be replayed.

Including the ratchet fingerprint in the Hello packet does not compromise identity hiding, because the ratchet fingerprint is replaced with every single handshake. In the event that Bob’s private keys are compromised, and all ratchet fingerprints used in Hello packets to Bob can be decrypted, all an attacker would see are several indistinguishable 256-bit strings. The one exception is if a peer reuses the same ratchet fingerprint. This would allow an attacker who has compromised Bob’s static private key to learn that two Hello packets come from the same peer, but this does not given any information about that peer’s static keys or identity. Ratchet fingerprints in normal operation are never reused, this can only happen if the initial Noise XK handshake is aborted before completion, preventing one or more of the participating peers from confirming a new ratchet fingerprint.

A rathet fingerprint, being an independently derived ASK, leaks no information about its associated ratchet key. In the event the value of a ratchet fingerprint is leaked to an attacker, it can only temporarily be used to violate the “Silence is Golden” property.

Packet types X_2 and K_1 represent the second to last message of Noise XK and Noise KK. The remote peer will not have derived the Noise key yet, so if this peer attempted to encrypt with this key immediately, there is a risk its packets will arrive out of order and be undecryptable. Receiving a valid C_1 packet from the remote peer confirms that they have successfully derived the correct Noise key, which signals it can now be reliably used for encryption.

Similarly, the new ratchet key and fingerprint will not have been derived by the remote peer yet. So this peer will have to save these keys to persistent storage, but not yet delete the previous ratchet key and fingerprint until the remote peer sends a key confirmation. This means that for a brief period of time Alice has two sets of ratchet keys and fingerprints saved, instead of just one. We want to make sure Alice and Bob never have more than two of these keys saved at a time. So during the Noise XK handshake if Alice has two sets of keys and fingerprints, they *must* send both fingerprints to Bob, and delete the key and fingerprint that Bob chooses not to use as the PSK.

When packet X_3 is received, Bob might refuse to start a session with Alice based on their static key and identity. The preferred way for Bob to do this is to simply do nothing, and ignore Alice’s packets. This would follow the “Silence is Golden” principle of security. However there are some applications where, usually for UX reasons, Alice needs to be able tell apart having a bad connection with Bob from Bob rejecting Alice’s identity. If Bob always goes silent, Alice has no reliable way to tell these two situations apart. This is the reason why packet D is created and sent at the bottom of [Algorithm 4](#). Receipt of packet D implies Bob has explicitly rejected a session with Alice.

Packet types X_3 and K_2 represent the final messages of Noise XK and Noise KK, respectively. The peer who receives these packets can be sure that the remote peer has derived an identical Noise key already, and so the new key can be reliably used immediately.

Packet types C_2 and D have trivial transition algorithms. They merely decrypt the received packet with the most recent key exchange key, kek_r^i . If authentication succeeds then ζ transitions state.

We want to minimize the number of Noise keys alive in memory for the sake of perfect forward secrecy, in case the content of a peer’s memory is stolen by an attacker. However we have to keep at least the last 2 keys around for reliability. Otherwise a packet that was sent before rekeying could arrive out of order, after the rekey is completed, and not be decryptable.

4.4 Security Flags

ZKE has 4 security flags, π_1, π_2, π_3 and π_4 . Each of these flags is a bit that, when set to 1, change the behavior of the protocol to be more secure. In particular, setting $\pi_2 = \pi_3 = 1$ dramatically improve ZKE’s post-compromise resistance, and setting $\pi_1 = \pi_4 = 1$ obeys the “Silence is Golden” principle of security. However setting these flags to 1 come with usability downsides that could make ZKE unsuitable for particular applications or particular users. Hence why these features are flags that the upper protocol is allowed to choose between.

Below is a description of each security flag, and the security versus usability tradeoff that occurs when it is set to 1. It should be noted that all communicating peers need not have the exact same set of flags. It will be possible for them to communicate even if their flags differ. Also, a peer may set their flags per remote peer, this is why flags π_3 and π_4 are returned by a function that takes as input the identity of the remote peer. This would, for example, allow a user to place much stricter authentication requirements upon a credentials server than a friend’s laptop.

- Hello Requires Recognized Ratchet, π_1 – Used in [Algorithm 2](#). When this flag is set Alice is required to present a recognized, nonzero ratchet fingerprint, or else Bob will remain silent. This satisfies the

Silence is Golden principle of security, since a peer can only acquire a valid ratchet fingerprint through some pre-existing trust relationship. However, this means a legitimate Alice must establish out-of-band an initial ratchet key and fingerprint with Bob. Bob and Alice can share a one time password to be used as the first ratchet key and fingerprint, or Bob can connect to Alice first if Alice has $\pi_1 = 0$, or Bob can temporarily set $\pi_1 = 0$ until Alice has completed their first key exchange.

- Initiator Disallows Downgrade, π_2 – Used in [Algorithm 3](#). When this flag is set Alice is resistant to Compromise-And-Impersonate and MitM, because Alice will never allow their ratchet key to be reset to zero. However it requires that Bob never accidentally corrupt their persistent ratchet key.
- Responder Disallows Downgrade, π_3 – Used in [Algorithm 4](#). When this flag is set Bob is resistant to Compromise-And-Impersonate and MitM, because Bob will never allow their ratchet key to be reset to zero. However it requires that Alice never accidentally corrupt their ratchet key. It is recommended that $\pi_2 = \pi_3$ for any given pair of peers.
- Responder Silently Rejects, π_4 – Used in [Algorithm 4](#). When this flag is set Bob will not send a session rejected packet to Alice, but instead just silently ignore Alice if Bob does not approve of their identity. This also follows the Silence is Golden principle, but it prevents Alice from knowing Bob will never allow Alice to connect in their current configuration. In this state Alice will keep attempting the handshake until the upper protocol times-out the session. It is recommended that $\pi_1 = \pi_4$ for any given pair of peers.

When $\pi_2 = \pi_3 = 1$, ZKE strictly requires all users to either have access to reliable persistent storage, or have access to some out-of-band mechanism for one to be reauthenticated in the event they lose or corrupt their persistent storage. This, unfortunately, is not always feasible in a real-time environment. For one thing there are many embedded devices which only have access to persistent ROM, but for another, there are far too many realistic scenarios in which an inexperienced user accidentally loses or corrupts their persistent storage. People often do not realize that they cannot always rollback an application’s data directory to a previously backed-up state, and expect the application to work. Furthermore, very few people have redundant drives, as in RAID, so a hard drive failure will likely cause them to lose most if not all of their ratchet keys. When a user can no longer connect with peers because they have corrupted their ratchet keys, some will perceive this as a bug with the application, rather than the protocol working as intended.

Furthermore there are many situations where implementing an out-of-band mechanism for reauthenticating peers would be too impractical or too insecure. While friends and medium sized-teams can simply message each other over a secure channel to request reauthentication, this solution might not scale to a network of thousands of devices, especially when one or more users don’t understand why the application stopped working. This kind of situation often unintentionally incentivizes the use of insecure channels for user to request reauthentication, channels vulnerable to phishing or social engineering. In a sense, security flags π_2 and π_3 provide an optional, in-band mechanism for users to automatically request reauthentication. While this mechanism is inherently more vulnerable to post-compromise attacks, it is resistant to phishing and social engineering.

With all of those disclaimers out of the way, however, we still highly recommend setting as many of these flags to 1 as practical, and for every flag that is 0, always allow a power user to override the flag to 1. Since peers with different flags can still communicate there is not much point in preventing a confident user from improving their end to end security.

5 ZeroTier Challenge Protocol

There is a fundamental computational asymmetry within nearly all public key protocols, and that is the fact that authenticity of the initial Hello packet usually cannot be determined until after some form of public key algorithm is computed. This means that an attacker is simply able to create a fake Hello packet *once*, and then spam it over and over again to cause the recipient, Bob, to compute tons of public key cryptography. If the attacker’s goal is to simply exhaust all computational resources of the Bob as a component of a DOS attack, then it does not matter whether or not their packets fail authentication. If each of their Hello packets can trigger even a single public key computation, then their attack can be successful. It is hard to understate

just how expensive public key cryptography is to compute, it is many orders of magnitude more expensive than most symmetric cryptography. For this reason, we have created a DOS mitigation protocol, inspired by the DOS mitigation protocol of WireGuard [2].

ZCP is a generic challenge-response protocol designed to mitigate CPU exhaustion attacks that spam the first Hello packet of a key exchange. While it was designed for ZSSP, it is in no way dependent on ZSSP to function, and could easily be adopted by other key exchange protocols. We will be describing ZCP in generic, protocol-independent terms, but it should be clear how the protocol is implemented as a component of ZSSP.

One of the most common forms of DOS attacks is the volumetric DDOS attack. This is where a large number of remote machines saturate the connection bandwidth of Bob with large amounts of spam. Within the constraints of the Internet Protocol, it is ultimately impossible in all cases to prevent this kind of attack, so long as the attacker has access to a higher bandwidth than Bob. For this reason our goal is to simply make a volumetric DDOS attack the easiest and cheapest form of DOS attack that can be performed against ZSSP.

Without some kind of mitigation, an attacker consume a small amount of their bandwidth and very little of their compute to send a Hello packet, which consumes a large amount of Bob’s compute. To correct this asymmetric resource consumption, we are going to create a form of challenge-response protocol using SHA-512, which will require a proof of IP address ownership and a proof of work. If Alice does not respond correctly to the challenge, Bob will issue a new challenge, and then drop Alice’s Hello packet. An attacker who does not respond to the challenge can only cause Bob to compute SHA-512 up to 3 times, which is many thousands times faster than processing the Hello packet of ZSSP.

The protocol is initialized with a random 256-bit string **salt**. As the name implies, this will be used as a salt for SHA-512. When Alice sends their first Hello packet, they execute **Algorithm 11**, and append the output to their Hello packet. Under normal conditions Bob will simply ignore this part of Alice’s Hello packet and allow the key exchange protocol to proceed. However if Bob is under load, Bob may choose to execute **Algorithm 12**. This algorithm is overwhelmingly likely to output a **challenge**, which is then sent to Alice. Alice then computes **Algorithm 13** upon Bob’s **challenge**, which outputs a **response**. **response** is re-appended to Alice’s Hello packet, and it is resent to Bob. Both **response** and **challenge** are a sequence of bytes with identical internal structure, documented in **Figure 11**.

Figure 11: Bob’s Challenge **challenge**, and Alice’s Response **response** – This is the internal structure of both the challenge and response strings Alice and Bob send each other. They are included as payloads within a larger packet.

Figure 12: Challenge Packet – Whereas Alice’s response is sent appended to their Hello packet, Bob’s challenge is sent on its own. This usually means it requires a small amount of framing to be considered a well-formed packet that Alice can receive. The “Peer Identifier” is defined by the upper protocol to allow for multiplexing between multiple peers. In ZSSP, the Peer Identifier is set to the key id included in Alice’s Hello packet, $X_1.key_id$. In ZSSP challenge packets are identified with packet type number ‘9’.

To challenge Alice to proof address ownership, Bob will send a counter value, for replay protection, and a MAC that is a salted hash of the counter and Alice’s address. Alice is expected to include in their next **response** the same counter and MAC, proving they can send and receive packets from their address. Attackers who are spoofing their address would not be able to receive nor reply to Bob’s challenge. Many

DDOS attacks, however, are performed using botnets of computers infected with malware. Each of these computers usually has access to a static address it can stage an attack from, which would allow it to respond to the challenge. Hence Bob also requires a proof of work from Alice.

To challenge Alice to prove work, Bob will require Alice to find a 64-bit string that, when appended to their counter and MAC, produces a hash with N leading zeros. In order to do this we expect Alice will have to compute SHA-512 2^N times, which is a proof of work. N is a static protocol constant. We recommend setting N to be the smallest value that makes computing the proof of work, [Algorithm 13](#), take more time on average than it takes the key exchange protocol to process Alice’s Hello packet. For ZSSP we have found this value to be $N = 13$. This method of choosing N minimizes the burden on legitimate peers while still eliminating the computational asymmetry between an attacker spamming Hello packets and Bob processing them. This, in general, should make a CPU exhaustion attack more expensive than a volumetric DDOS attack.

Finally, to mitigate the possibility that the proof of work itself becomes a CPU exhaustion vector, Bob is required to “prove receipt” of Alice’s response. Bob must include the 64-bit proof of work field sent by Alice in their challenge to Alice. If Alice sees that their proof of work is not included in Bob’s challenge, Alice will ignore the challenge. This makes it difficult for an attacker to spoof a challenge to look like it came from Bob. The attacker would have to be able to read Alice’s Hello packet and send their fake challenge before Bob sends the real challenge. The average botnet DDOS attacker is not capable of doing this. Using the proof of work for this purpose has the advantage of making it trivial to serialize each of Alice’s executions of [Algorithm 13](#), rate limiting the proof of work and preventing more than one CPU core from being consumed. The proof of receipt could be made more effective if it was also a salted hash of a counter and Bob’s address, but we felt that the current design was more than enough to make CPU exhaustion attacks more expensive than volumetric DDOS attacks. It is recommended that Alice has a mechanism to eventually timeout their key exchange with Bob if Bob has done nothing but send challenges.

To prevent a legitimate Alice from unintentionally straining Bob while Bob is under load, Alice should not immediately resend their Hello packet upon receipt of a **challenge**. Instead Alice should wait until they would normal resend their Hello packet.

Implementations may choose to rotate the **salt** variable periodically. While the protocol as we have described it so far has strong replay protection, it does not automatically expire sent challenges after a set amount of time. This means challenges might never expire, and could be saved up to be used later. We do not consider this a practical DOS attack vector, but for applications that do, rotating **salt** on a periodic schedule is one of the best solutions.

If \perp is returned, this means Bob will not be sent a challenge packet, but instead Alice’s Hello packet will be allowed to be processed by the upper protocol.

We have intentionally avoided involving any of the cryptographic variables from the upper key exchange protocol in this protocol. This is to enforce strict protocol independence, to avoid accidentally compromising some security property of the key exchange protocol. In particular this protocol will preserve identity hiding, since neither Bob nor Alice include static, identifying values in their challenge or response. From an analytical perspective, within most AKE security experiments, we can almost always prove that the security of a key exchange protocol plus ZCP can be reduced to the security of just the key exchange protocol. This is because an adversary which just attacks the key exchange is always capable of accurately simulating both Alice and Bob’s side of ZCP to an adversary which attacks both the key exchange and ZCP.

This protocol violates the Silence is Golden principle of security. So we recommend disabling it entirely if security flag $\pi_1 = 1$. In general we expect many administrators will have this protocol turned off by default, but will manually enable it in the event a CPU exhaustion attack is detected. Just the fact that this protocol is available to be enabled at any time will likely deter attackers from performing a CPU exhaustion attack against ZSSP.

6 ZeroTier Fragmentation Protocol

ZSSP supports the partitioning of large packets into smaller fragments, that can each be sent individually between peers, and will be reassembled at the other end. Most datagram protocols have a maximum transmission unit (MTU), that all packets must be smaller than. Fragmentation makes it possible for the upper protocol to send packets much larger than the MTU. The MTU of UDP is inconsistent and can go as low as 1280 bytes. And if we consider non-IP networks, MTU can go as low as just a few hundred bytes. While many applications would work with small MTU, they might not work efficiently, and having such low MTUs even as just a possibility often greatly hinders the design of a protocol, and what platforms it can support. To make real-time networking operate reliably and efficiently on top of links with low MTU, fragmentation is necessary.

ZFP is responsible for fragmentation within ZSSP. It sits at the very bottom of the ZSSP protocol stack, just above the datagram protocol. We have chosen to put the fragmentation protocol at the bottom of the ZSSP stack, instead of the top for a few reasons. First and foremost it allows key exchange packets to be as large as we need, larger than the MTU of the underlying datagram protocol. This allows us to use P384 and Kyber1024 keys, instead of their smaller and less secure variants. The second reason is that it allows the bandwidth overhead of fragmentation to be extremely small, just 16 bytes per fragment. If the fragmentation protocol were at the top of the stack instead, then each fragment would have required an additional 16 bytes for each MAC. This also benefits efficiency, because it reduces the number of MACs that must be computed and subsequently verified.

Given a packet, P , from the upper protocol, and a MTU, M , that is greater than 127, there is exactly one canonical way to fragment it to fit within the MTU. Set the *fragment count*, C , to $\lceil |P|/(M - 16) \rceil$, where $|P|$ is the size of the packet in bytes. The fragment count is the total number of fragments we will be splitting the original packet into. Each fragment will be assigned a *fragment number*, from 0 to $C - 1$, to indicate their order in the original packet. Each fragment will have a 16 byte *fragment header* followed by a *payload*. The fragments assigned numbers 0 to $|P|\%C - 1$ must have a *payload* of size $\lfloor |P|/C \rfloor + 1$. And fragments assigned numbers $|P|\%C$ to $C - 1$ must have a payload of size $\lfloor |P|/C \rfloor$. It can be shown that this guarantees each fragment will at most M bytes long. When each payload is concatenate in fragment number order, the result must be equal to the original packet, P . This fragmentation scheme was chosen to prevent miniscule payloads from being generated, to allow implementations to accurately estimate $|P|$ given any one fragment, and to keep fragments from the same packet roughly the same size.

The upper protocol must identify every packet with a *packet nonce*. For each fragmented payload, take the fragment number, fragment count and a packet nonce, and combine them according to [Figure 13](#) to create a *fragment header*. Then append each payload to its header to create the final set of *fragments*. These fragments are then individually sent to the remote peer over the lower datagram protocol.

Implementations must support a fragment count of at least 48. Implementations may choose and enforce a maximum length of the final reassembled packet. Since fragment numbers and counts are stored as 1 byte integers, the maximum possible fragment count that can be encoded is 256. If the fragment count for a packet is 256, the fragment count field of the packet header should be set to 0. Implementations that choose to support fragment counts of 256 must interpret a 0 in the fragment count field as a fragment count of 256.

Figure 13: Header of the ZeroTier Fragmentation Protocol – The “Peer Identifier” is given by the upper protocol to allow for multiplexing between multiple peers. In ZSSP, the Peer Identifier is set to the most recent key id of the remote peer. The “Packet Nonce” is also given by the upper protocol, it is expected to contain metadata on behalf of the upper protocol, and as the name implies it should be unique per packet. [Figure 14](#) describes how this Nonce is constructed in ZSSP.

Each peer must statefully maintain a datastructure called a defragmentation buffer to reassemble fragmented packets. The buffer uses the packet nonce to know which packet each fragment is a component of, it uses the fragment number to know which part of the packet the fragment’s payload maps to, and it uses the fragment count to know when all fragments have been received. Once all payloads have been received the defragmentation buffer will concatenate all of them together to reassemble the original packet. That packet is then passed to the upper protocol.

6.1 Authenticated Fragment Headers

If all ZFP contained was a fragmentation scheme and defragmentation buffer, then it would be trivial for an attacker to inject arbitrary fragments to corrupt packets. Nothing described so far actually authenticates the fragment count, fragment number or packet nonce. For a time this was considered acceptable, because after all, the rest of ZSSP aggressively authenticates packets, meaning that even if a packet is corrupted at this protocol layer, it will be rejected by the upper layers. However, this protocol layer is vulnerable to a type of DOS attack, where an attacker spams corrupted fragments to constantly keep the defragmentation buffer full. We consider this unacceptable, since it would allow an attacker to consume a small amount of their bandwidth and compute to near completely prevent a legitimate peer from receiving uncorrupted packets from another peer.

One solution is to simply massively increase the size of the defragmentation buffer. With access to more memory, it becomes significantly harder for an attacker to completely fill it with corrupted fragments. However, we were not happy with the idea of dramatically increasing the memory consumption of ZSSP. Also, this mitigation does not address a variant of this DOS attack, that is based on consistently predicting the next packet nonce that will be used, to target the legitimate packet assigned it.

The proper solution to this problem is to authenticate the fragment count, fragment number and packet nonce. To do this, ZFP assumes access to two preshared 256-bit symmetric keys. This will be called the header keys, or hk , and the Zeta Key Exchange produces these keys as ASKs from the very first message of Noise XK. Each peer treats one of these keys as a sending key, and the other as a receiving key. Since our goal is to simply mitigate DOS attacks against the defragmentation buffer, we consider full AEAD encryption of the header with a 16 byte authentication tag to be overkill. Instead, we are going to take advantage of the fact that all 3 values we wish to authenticate fit within a single AES block, and that one of them is explicitly a nonce.

After all fragments are constructed, AES-256 [16] is used to directly encrypt in-place bytes 4 through 20 of each fragment, using the peer’s sending key. When a fragment is received, AES-256 is used to decrypt bytes 4 through 20 using the peer’s receiving key. Immediately after the packet is decrypted, the packet nonce is given to the upper protocol to check if it is valid and unique. If it is not valid then the fragment is dropped. If it is valid then it is allowed to enter the defragmentation buffer. It is exactly this check which allows this algorithm to provide authentication, albeit with a low amount of cryptographic entropy.

Bytes 4 through 20 of a fragment include the fragment number, fragment count, packet nonce, and the first 4 bytes of the payload. The packet nonce, in combination with the fragment number, guarantees each block fed into AES will be strictly unique, thereby guaranteeing every header will have a unique encryption. We allow the first 4 bytes of the payload to be included in the block because it is simpler to implement, and it could help in the event a packet nonce is reused due to implementation error.

We prove in [Theorem 1](#) that, under the assumption AES-256 is a pseudo-random permutation, and the header key is indistinguishable from random, that the ZFP header authentication algorithm is existentially unforgeable under an adaptive chosen message attack. We also demonstrate that the probability an attacker is able to forge a valid header is bound above by the probability that the upper protocol considers a uniform random packet nonce to be valid. For ZSSP, this implies that the probability an attacker forges a valid header is bound above by $\text{negl}(n) + 2^{-45}$, where $\text{negl}(n)$ is the probability that an attacker is able to break AES-256.

While this probability is not low enough to be considered cryptographically secure, it is more than plenty for making a defragmentation DOS attack more expensive than a volumetric DDOS attack. It should be emphasized that this authentication mechanism is only sufficient for defending against DOS attacks, ZSSP does not rely on it for anything more than that.

One secondary benefit of this algorithm is that it encrypts the packet nonce. This means that an attacker without the header key cannot see the ZSSP packet type or counter of a packet. Neither of these values are particularly sensitive, but in certain contexts they can aide an attacker in fingerprinting communicating peers or performing traffic analysis. We consider this benefit non-essential but nice to have.

6.2 Hello Packet Fragmentation

Alice and Bob do not share a header key prior to Alice sending the first Hello packet. For this reason we cannot authenticate the headers of their Hello packet fragments using the previously described algorithm. So instead, we simply do not attempt to authenticate Hello packet headers. All Hello packet fragments from all peers enter a single defragmentation buffer. This defragmentation buffer is larger than a session defragmentation buffer.

The Hello packet defragmentation buffer is significantly easier to DOS than a session defragmentation buffer. But so long as Alice can get a single Hello packet through to Bob uncorrupted, Alice will be able to then onwards communicate with their own personal session defragmentation buffer using header authentication. Without at least a symmetric key, we do not believe much more can be done to mitigate DOS attacks against a defragmentation buffer. We cannot use a symmetric key derived from Bob's static public key or identity because this would violate identity hiding, by making it possible for an attacker to test candidate public keys.

The challenge packet, [Figure 12](#), is small enough that it never requires fragmentation. So Bob does not use the header key to authenticate the header of the challenge packet they send Alice. Bob would not be able to derive the header key anyways, since Bob has not processed Alice's Hello packet. The last 8 bytes of the packet nonce are randomized so challenge packets do not collide with each other. The Noise XK handshake packets, as specified by Noise, do not use a unique counter, but instead use counter values of 0 or 1. This creates a problem for fragmenting Hello packets, X_1 and Response packets, X_2 , because we need a way for each of these packets to be fragmented with unique packet nonce values, and not just packet nonce values of $0||0$ and $1||0$. Otherwise, these packets will end up colliding and corrupting each other in the defragmentation buffer. For X_1 packets, the last 8 bytes of the final AES-GCM MAC is used as the counter value within the packet nonce. This essentially treats the MAC as a random number which is attached to each fragment. The MAC was chosen instead of an actual random number because it allows Bob to trivially authenticate that the received packet nonce is exactly the packet nonce Alice sent, by simply checking if it is equal to the MAC. A modification of this policy is used for X_2 packets. Since we use ZPF authenticated headers with the fragments of X_2 packets, to provide robust authentication we want the counter value used to always be in a 2^{16} integer range. For this reason we only use the last 2 bytes of the final AES-GCM MAC as the random counter value for the packet nonce of X_2 fragments. The risk of accidental collision is far, far less than that of X_1 packets, so we consider 2 bytes sufficient. X_3 use a counter value of 0, since, due to the structure of ZKE, a packet nonce of $2||0$ will always be unique for the X_3 packet of a given key exchange. Both peers have synchronized state at this point in the handshake, so Alice can statefully prevent two different, colliding X_3 packets from being generated.

6.3 Mathematical Background

We are going to prove that the ZFP header authentication algorithm is existentially unforgeable under an adaptive chosen message attack. However our algorithm does not fit the standard syntax of message authentication codes. This means we must prove security under a different security experiment than the standard message authentication code experiment. We choose to use the syntax of a message transmission scheme [\[17\]](#), and prove authenticated communication under the secure message transmission experiment, [Algorithm 14](#).

Definition 12 (H). [Message Transmission Scheme [\[17\]](#)] A message transmission scheme is a tuple of algorithms $\Pi = (\text{Gen}, \text{EncMac}, \text{Dec})$. Gen is the key generation algorithm, EncMac is the authenticated encryption

algorithm, and Dec is the decryption and verification algorithm.

A message transmission scheme is *correct* if for all keys $k \leftarrow \text{Gen}(1^n)$ and messages m ,

$$\text{Dec}_k(\text{EncMac}_k(m)) = m.$$

Definition 14 (H). [Pseudorandom Permutation [17]] Given the security parameter n , a keyed permutation, $F_k : \{0, 1\}^n \rightarrow \{0, 1\}^n$, and a probabilistic poly-time distinguishers D , define the advantage of D to be:

$$\text{Adv}_{D, F}^{\text{ind-prp}}(n) = |\Pr[D^{F_k(\cdot), F_k^{-1}(\cdot)}(1^n) = 1] - \Pr[D^{f(\cdot), f^{-1}(\cdot)}(1^n) = 1]|,$$

where $k \leftarrow \$\{0, 1\}^n$ and $f : \{0, 1\}^n \rightarrow \{0, 1\}^n$ is a truly random permutation.

An efficient, keyed permutation, F_k , is a strong pseudorandom permutation if for all probabilistic poly-time distinguishers D , there exists a negligible function negl such that:

$$\text{Adv}_{D, F}^{\text{ind-prp}}(n) \leq \text{negl}(n),$$

6.4 Proof of Security

Algorithms [Algorithm 15](#), [Algorithm 16](#), and [Algorithm 17](#) define the ZFP header authentication algorithm using the syntax of a Message Transmission Scheme, [Definition 12](#). These definitions are then used in [Theorem 1](#) to reduce the security of the ZFP header authentication algorithm to the security of AES-256.

Algorithm 15 $\text{Gen}(1^n)$ of the ZFP header authentication algorithm – We are implicitly assuming here that the header key is truly random, or at least computationally indistinguishable from random.

Algorithm 16 $\text{EncMac}_k(m)$ of the ZFP header authentication algorithm – Input m is bytes 4 to 20 of a fragment, which is the portion of the fragment that ZFP encrypts. Function F is AES-256. For the sake of the security proof we will assume that the input block size of AES-256 is not constant, but instead is equal to n . For this reason we also assume m is able to grow to be of size n .

Output: $F_k(m)$

Algorithm 17 $\text{Dec}_k(c)$ of the ZFP header authentication algorithm – Function F^{-1} is inverse of AES-256. Function Vrfy is some algorithm provided by the upper protocol for verifying that the packet nonce is valid. For the sake of the security proof we assume that the the packet nonce N is able to grow in size proportional to n . The version of Vrfy used by ZFP is described by [Algorithm 19](#).

Theorem 1 (H). If $F_k : \{0, 1\}^n \rightarrow \{0, 1\}^n$ is a strong pseudorandom permutation, and $\Pr[\text{Vrfy}(N) = 1]$ is a negligible function in $|N|$ for uniform random N , then $\Pi = (\text{Algorithm 15}, \text{Algorithm 16}, \text{Algorithm 17})$ achieves authenticated communication, with advantage bound:

$$\Pr[\text{Auth}_{\mathcal{A}, \Pi}(n) = 1] \leq \text{Adv}_{D, F}^{\text{ind-prp}}(n) + \frac{2^n}{2^n - q(n)} \Pr[\text{Vrfy}(N) = 1],$$

where N is uniform random, and $q(n)$ is the upper bound on the total number of queries \mathcal{A} asks its oracle.

H. Given \mathcal{A} an adversary for $\Pi = (\text{Gen}, \text{EncMac}, \text{Dec})$, we construct D , [Algorithm 18](#), a distinguisher for F . Assume without loss of generality \mathcal{A} will never output a string which it has previously received from its oracle.

Since F is a strong pseudorandom permutation, we know it is the case that

$$|\Pr[D^{F_k(\cdot), F_k^{-1}(\cdot)}(1^n) = 1] - \Pr[D^{f(\cdot), f^{-1}(\cdot)}(1^n) = 1]| \leq \text{negl}(n),$$

where $k \leftarrow \mathcal{S}\{0, 1\}^n$ and f is a truly random permutation.

Since f is a truly random permutation, it is the case that $f^{-1}(\mathcal{A}^{f(\cdot)}(1^n))$ outputs a uniform random string, m , from the set of strings \mathcal{A} did not queried to $f(\cdot)$. Let Q be a random variable that represents the set of queries asked while executing $\mathcal{A}^{f(\cdot)}(1^n)$.

Let $m \in \{0, 1\}^n$ be a uniform random variable, and let $\mathcal{N}(m)$ be defined as the packet nonce of m .

$$\begin{aligned} \text{So } \Pr_f[D^{f(\cdot), f^{-1}(\cdot)}(1^n) = 1] &= \Pr[\text{Vrfy}(\mathcal{N}(f^{-1}(\mathcal{A}^{f(\cdot)}(1^n)))) = 1] \\ &= \Pr[\text{Vrfy}(\mathcal{N}(m)) = 1 \mid m \notin Q] \\ &= \frac{\Pr[\text{Vrfy}(\mathcal{N}(m)) = 1 \text{ and } m \notin Q]}{\Pr[m \notin Q]} \\ &\leq \frac{\Pr[\text{Vrfy}(\mathcal{N}(m)) = 1]}{1 - \frac{q(n)}{2^n}} \\ &= \frac{2^n}{2^n - q(n)} \Pr[\text{Vrfy}(N) = 1], \end{aligned}$$

where N is a uniform random packet nonce.

$$\begin{aligned}
\text{So } \Pr[\text{Auth}_{\mathcal{A}, \Pi}(n) = 1] &= \Pr[D^{F_k(\cdot), F_k^{-1}(\cdot)}(1^n) = 1] \\
&= \Pr[D^{F_k(\cdot), F_k^{-1}(\cdot)}(1^n) = 1] - \Pr[D^{f(\cdot), f^{-1}(\cdot)}(1^n) = 1] + \Pr[D^{f(\cdot), f^{-1}(\cdot)}(1^n) = 1] \\
&\leq \text{negl}(n) + \Pr[D^{f(\cdot), f^{-1}(\cdot)}(1^n) = 1] \\
&\leq \text{negl}(n) + \frac{2^n}{2^n - q(n)} \Pr[\text{Vrfy}(N) = 1].
\end{aligned}$$

□

Algorithm 19 The implementation of $\text{Vrfy}(N)$ for ZSSP – We are assuming that the input N is being interpreted as $p||c$, the packet nonce construction of Figure 14. D is a stateful, finite array of integers, initialized to -1, that stores the value of previously authenticated counters. D is updated after ZSSP decrypts a received packet. ZSSP explicitly does not verify that the padding is zero, for the sake of possible future revisions.

Algorithm 19 shows how ZSSP validates packet nonces. Notice that p must be in range 1 through 8 to be considered valid. Also notice that, regardless of the value of p , c must fall into some range of integers that is at most 2^{24} in size. If we assume the adversary makes no oracle queries, this implies that the advantage against ZSSP's header authentication is bound above by

$$\begin{aligned}
\Pr[\text{Auth}_{\mathcal{A}, \Pi}(n) = 1] &\leq \text{Adv}_{D, F}^{\text{ind-prp}}(n) + \Pr[\text{Vrfy}(N) = 1] \\
&\leq \text{negl}(n) + \frac{8}{2^8} \cdot \frac{2^{24}}{2^{64}} \\
&= \text{negl}(n) + 2^{-5} \cdot 2^{-40} \\
&= \text{negl}(n) + 2^{-45}.
\end{aligned}$$

If we assume the adversary does make oracle queries, then their advantage bound is only negligibly larger than the advantage above.

The range 2^{24} was chosen because it appears to be optimal for this application. One byte less of range, 2^{16} , makes it barely feasible for an attacker to drop 2^{16} of a peer's packets in a row. This would put the counter of future packets outside of the allowed range, and cause all future packets to be dropped. One byte more of range, 2^{32} , would make it easier than necessary for an attacker to forge a valid header.

The security experiment we have used does not consider replay protection, however it should be clear that Algorithm 19 does indeed provide replay protection. Once any packet is fully authenticated by ZSSP, and its counter is added to array D , it is the case that its packet nonce will no longer be valid according to

Algorithm 19. If a packet is dropped or corrupted, its fragments could only be replayed until some other received packet updated the relevant index of D . This prevents a type of DOS attack where the attacker simply replays valid fragments to keep the defragmentation buffer full.
